

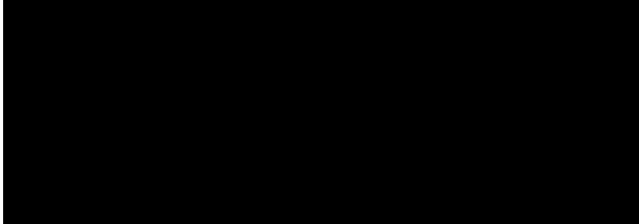

Dear Mercedes-Benz Owner:

The purpose of this letter is to advise you of additional benefits that Mercedes-Benz USA, LLC ("MBUSA") is providing to you regarding your vehicle ownership.

What's Included

In our continuing efforts to assure the proper performance of Mercedes-Benz products and to enhance the satisfaction of our customers, MBUSA is extending the warranty on the low pressure fuel hose that connects to the high pressure fuel pump. Under certain cold ambient conditions during a cold start of the engine, the low pressure fuel hose at that connection may experience slight fuel weeping. A brief fuel odor may be perceptible by the occupants, but a safety risk, including the risk of fire, can be ruled out.

The original New Vehicle Limited Warranty of 4 years / 50,000 miles for the vehicle's fuel hose is extended to **10 years/120,000 miles. This limited warranty extension to the existing fuel hose applies to the vehicle regardless of ownership.**

This extended warranty applies to all aforementioned conditions that necessitate the servicing and/or the replacement of the fuel hose under the New Vehicle Limited Warranty terms and conditions. The following vehicles are included in the extended warranty:

C-Class	2015	C300, C300-4M (Sedan)
C-Class	2016 - 2017	C300, C300-4M (Sedan), C300, C300-4M (Coupe), C350e (Hybrid)
E-Class	2017	E300, E300-4M (Sedan)
GLC-Class	2016 - 2017	GLC300, GLC300-4M
GLC-Class	2017	GLC300-4M (Coupe)
SLK-Class	2016	SLK300
SLC-Class	2017	SLC300

Any repairs under this warranty extension must be performed by an authorized Mercedes-Benz dealership. This extended warranty *does not* cover any other components beyond the one mentioned above, and standard warranty terms apply, including the exclusions with respect to extra expenses, as identified in the Service and Warranty Information booklet. In the case of failure of any component other than the aforementioned parts beyond any other applicable warranty coverages, the associated repair will not be covered and will remain your responsibility.

What if I already paid for a repair?

If your vehicle has exceeded the original New Vehicle Limited Warranty's mileage or time period, and you have already paid to have your fuel hose replaced due to the aforementioned issue, you may be eligible to receive reimbursement under this warranty extension. Reimbursement for your replacement costs can be obtained by presenting adequate documentation to your authorized Mercedes-Benz dealer. Requests for reimbursement may include expenses for Mercedes-Benz replacement parts, labor, fees, and taxes. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Mercedes-Benz dealer. Contact your Mercedes-Benz dealer for more information on obtaining this reimbursement. Repairs performed by a non-Mercedes-Benz dealership might not be reimbursed. Requests for reimbursement of the fuel hose replacement/repair costs that were not related to fuel seepage will not be honored.

Reimbursement to Customers for Valid Repairs Performed Prior to Receipt of this letter

If you have already paid to have any of the included components replaced, you may be eligible to receive reimbursement.

Requests for reimbursement may include parts, labor, fees and taxes.

Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Mercedes-Benz dealer.

The following documentation must be presented to your servicing or closest Mercedes-Benz dealership for reimbursement.

Original or clear copy of **all** receipts, invoices and/or repair orders that show:

- The name and address of the person who paid for the repair.
- The Vehicle Identification Number (VIN) of the vehicle that was repaired.
- What problem occurred, what repair was done, when it was done and who repaired it.
- Only Mercedes-Benz replacement parts were used for the repair.
- Fault Code (DTCs) information belonging to this Warranty Extension (if any).
- The total cost of the repair expense that is being claimed.
- Proof of payment of repair (copy of front and back of cancelled check, or copy of credit card receipt).
- **Reimbursement will be paid by a check from your authorized Mercedes-Benz dealer.**
