1. BACKGROUND

- 1.1. THE PURCHASER UNDERSTANDS AND AGREES THAT THIS AGREEMENT IS NOT A POLICY OR CONTRACT OF INSURANCE, AND THAT THE PURCHASE OF THIS AGREEMENT IS NOT REQUIRED IN ORDER TO PURCHASE OR OBTAIN FINANCINGFOR A MOTOR VEHICLE.
- 1.2. This Mercedes-Benz Certified Pre-Owned Extended Limited Warranty (this "Agreement") applies only to repairs to the Vehicle covered by this Agreement occurring within the United States and Puerto Rico.
- 1.3. Term and Mileage Expiration Coverage under this Agreement (the "Term"):
 - 1.3.1. begins after the expiration by time duration of the Mercedes-Benz Certified Pre-Owned Limited Warranty; and
 - 1.3.2. Ends on either the Agreement End Date, or the Vehicle reaching the maximum mileage limit indicated under the Agreement Type/Term, both as listed on page 1, whichever occurs first.
 - 1.3.3. The purchase of this Agreement does not waive any implied warranties that are available to You.
- 1.4. This Agreement may only be purchased while the Vehicle is covered by the Certified Pre-Owned Vehicle Limited Warranty.
- 1.5. The Vehicle is not covered if used for commercial purposes including "For-Hire" or commercial rental.
- 1.6. This Agreement is not valid for use in connection with Mercedes-Benz SLS, SLR, and AMG GT Black Series vehicles.
- 1.7. In the event that any provision of this Agreement is held by a court of competent jurisdiction to be unenforceable, the validity of theremaining provisions shall not be affected. The unenforceable provisions shall be replaced by mutually acceptable provisions which, being valid, legal, and enforceable, come closest to the intention of the parties underlying the invalid or unenforceable provision.

2. DEFINITIONS

- 2.1. We, Us, and Our: Mercedes-Benz USA, LLC (MBUSA), the party obligated to provide the services under this Agreement; One Mercedes-Benz Drive, Sandy Springs, GA 30328-4201; 1-800-FOR-MERCEDES (1-800-367-6372).
- 2.2. **You, Your, and Purchaser:** The party indicated as the "Purchaser" on page 1.
- 2.3. **Selling Dealer:** The Authorized Mercedes-Benz Dealer from whom You purchased this Agreement.
- 2.4. **Authorized Dealer:** Any authorized Mercedes-Benz Dealer in the United States or Puerto Rico.
- 2.5. **Private Party Purchaser:** Any subsequent purchaser of the Vehicle other than a motor vehicle dealer or a person actively engaged in the business of buying, selling or exchanging motor vehicles.
- 2.6. **No Charge:** Extended Limited Warranty services will be provided at no charge for parts, labor, or diagnostic operations which are directly related to the coverage provided under this Agreement.
- 2.7. Service Information Booklet: Manufacturer's manual containing maintenance work information utilized for the Vehicle's specific model, age, or mileage.
- 2.8. Vehicle or Motor Vehicle: The Mercedes-Benz vehicle specified on page 1, which cannot be used at any time during the term of this Agreement for professional emergency, law enforcement, for-hire, or commercial purposes.

3. WHAT IS COVERED

- 3.1. During the Term of this Agreement, all necessary repairs or replacements of the parts listed below will be made by any Authorized Dealer at no charge to You or any eligible subsequent Private Party Purchaser, to correct "defects" in material or workmanship in, and not "damage" to, covered vehicle parts and/or systems of the Vehicle.
- 3.2. This agreement covers all necessary repairs or replacement for the Vehicle of only the parts listed below.

- 3.2.1. ENGINE: Engine block, cylinder head(s), cylinder head gasket(s), all internally lubricated parts, including internally lubricated seals and gaskets, intake and exhaust manifolds, timing chain cover, flywheel, flex-plate, vibration damper (harmonic balancer), coolant pump, turbocharger, supercharger, belt tensioners, injection pump, controlmodule, and motor mounts.
- 3.2.2. TRANSMISSION: Transmission case, control module, all internally lubricated parts, including internally lubricated seals and gaskets, valve body, automatic transmission metal lines, torque converter, modulator control valve, control pressure cable, shift linkage(s), clutch hydraulic cylinders, clutch disc, pressure plate, clutch release bearing and fork for vehicles equipped with a manual transmission.
- 3.2.3. AXLES: Center section/rear axle and all internally lubricated parts, including internally lubricated seals and gasket, axle side shafts, drive shaft, drive shaft center bearing, drive shaft flex-disc assembly, rear axle shaft bearings and hubs.
- 3.2.4. ELECTRONIC STABILITY PROGRAM (ESP): Control module, wheel speed sensors, hydraulic pump and electric motor, all hydraulic lines and lateral acceleration sensors.
- 3.2.5. AUTOMATIC SLIP DIFFERENTIAL (ASD): All hydraulic system components including pump, pressure lines, solenoid/valves and control module.
- 3.2.6. ELECTRONIC TRACTION SYSTEM (ETS): Hydraulic unit (ABS/ETS), charging pump, pressure reservoir, control module, vehicle speed sensors.
- 3.2.7. **ACCELERATION SLIP REGULATION (ASR):** Hydraulic unit (ABS/ASR), charging pump, pressure reservoir and control module.
- 3.2.8. 4-MATIC MODELS ONLY: Transfer case, front axle, centersection and all internally lubricated parts, including internally lubricated seals and gaskets, front drive shaft, front axle shaft, bearings, wheel speed sensors and hubs.

- 3.2.9. G-CLASS MODELS ONLY: Transfer case, transfer case shift motor, front axle, including seals and gaskets, front drive shaft, front axle shaft, bearings, wheel speed sensors and hubs.
- 3.2.10. **COOLING SYSTEM:** Thermostat, radiator, fan clutch, engine fan (including electronic fan), coolant expansion tank, transmission and engine oil coolers as well as the metal lines and fitting.
- 3.2.11. FUEL INJECTION SYSTEM: Vacuum shutoff, vacuum control valve, ALDA/BCAPA (barometric pressure-charge air compensation) unit, fuel pump, cold start valve, fuel pressure regulator, fuel injectors (gas and diesel), fuel injector holders, all metal high pressure fuel injection lines and return lines, warm-up regulator, fuel accumulator, fuel distributor, mass/volume air flow sensor, primary pressure regulator, engine idle speed control valve, fuel heater (diesel only), throttle linkage assembly, fuel tank and expansion tank.
- 3.2.12. **STEERING SYSTEM:** Power steering gear box including PML control valve, pump, pump pulley, ignition lock including cylinder / tumblers, drag link, steering shock absorber, steering knuckle, tie rods, idler arm and idler arm bushing.
- 3.2.13. SUSPENSION: Coil springs, anti-sway torsion bar as well as associated linkage and brackets, ADS pump (where applicable), reservoir, valves, accumulators, valve linkage, suspension pressure reservoir, gas spring reservoir, oil reservoir and cover, oil level sending unit, high-pressure oilhose, distribution valve, switch level adjustment, solenoid locking valve, suspension acceleration sensor, body acceleration sensor, switch load sensor, upper and lower control arms, as well as all suspension links and bushings, ball joints, wheel bearings, wheel bearing seals and air suspension struts.
- 3.2.14. BRAKE SYSTEM: Master cylinder, brake booster, Brake Operating Unit including BOU sensors, vacuum pump, hydraulic unit (ABS or ABS/ETS/ASR/ESP/SBS) wheel speed sensors, brake calipers, proportioning valve, metal and composite hydraulic lines and fittings.
- 3.2.15. **ELECTRICAL SYSTEM:** Ignition coils and secondary wiring, starter system components, as well as all electrical motors, wiring harnesses

and connectors, starter lockout switch, sending units, sensors, switches, fuse boxes, relay modules, control modules, transmitters, instrument panel, gauges, rheostats, potentiometers, blower motor series resistors, alternator pulley, voltage regulator, diodes, buzzers, horns, actuators, timers, electro-mechanical valves, solenoids, as well as air bag contact plate (located in steering wheel), heated seat elements, and global positioning system (GPS).

- 3.2.16. CLIMATE CONTROL: All electrical components noted above, as well as the A/C compressor and clutch, receiver/drier bottle, refrigerant hoses and connections, evaporator, expansion valve, condenser, rear vent control cables, vacuum actuators, all vacuum valves and elements, auxiliary cooling pump, cold engine lock-out switch, temperature selector wheel, servo unit, mono valve,dual valve, switchover valve, heater core and heater housing assembly.
- 3.2.17. BODY: Window regulators, sunroof cables, front and rear windshield wiper linkages, power seat drive cables and seat belt assemblies.
- 3.2.18. **CENTRAL LOCKING SYSTEM:** Actuator/element, pneumatic check valve, switches and linkages.
- 3.2.19. **REMOTE CENTRAL LOCKING:** Transmitters (excluding batteries) and receivers.*
- 3.2.20. CLOSING ASSIST: Actuators, switches, and supply pump.*
- 3.2.21. **SOFT TOP/RETRACTABLE HARDTOP**: Mechanical linkages, hydraulic unit, valves/solenoids, switches and sensors.*
- 3.2.22. ROLL BAR SYSTEM: Roll bar mechanism or complete assembly; roll bar, hydraulic cylinders, hydraulic unit, valves / solenoids, actuators, and switches.*
- 3.2.23. AUDIO AND NAVIGATION SYSTEMS: Head unit (Radio, AM/FM/Weatherband/Satellite), speakers, audio amplification system, CD player and changer, associated electrical wiring,

- instruments, fleetboard, and navigation system installed by factory or authorized Mercedes-Benz Dealer using approved Mercedes-Benz components.
- 3.2.24. SATELLITE RADIO SYSTEM: All components of satellite radios are covered under this warranty if they have been installed at the factory or by an Authorized Dealer using approved components.
- 3.2.25. **NAVIGATION SYSTEM**: DVD drive/hard drive, control module, antenna system.*
- 3.2.26. **OPTICAL NETWORK**: Fiber optics and connectors associated with optical componentry.
- 3.2.27. COMMAND: Control display unit, central processor, steering wheel control system, integrated CD/DVD drive, integrated Navigation processor, GPS antenna system, and Navigation DVD drive/hard drive.
- 3.2.28. **HYBRID/ELECTRIC VEHICLES**: High-Voltage Battery coolant system, Electric Drive motors, Regenerative Braking System components.*
- 3.3. ANY SERVICING, REPAIRS OR REPLACEMENTS FOR ANY "DEFECTS" IN MATERIAL OR WORKMANSHIP WILL BE MADE ASDETERMINED BY MBUSA, USING NEW OR REMANUFACTURED GENUINE MERCEDES-BENZ PARTS AT MBUSA'S SOLE DISCRETION.
 - 3.3.1. In the case of defective assemblies, factory rebuilt units may be used in exchange instead of their repair.
 - 3.3.2. Any defective parts or assemblies replaced under this Agreement shall become the property of MBUSA.

*COVERAGE UNDER THIS AGREEMENT APPLIES TO VEHICLES BEARING THESE ITEMS AS ORIGINAL EQUIPMENT ONLY

4. CONDITIONS AND VEHICLE SERVICE REQUIREMENTS FOR YOUR WARRANTY

- 4.1. MBUSA will, during the Term of this Agreement, only repair or replace any parts of the Vehicle listed above due to any "defects" in material orworkmanship, and not "damage." You must properly maintain and care for the Vehicle, and any repairs covered under this Agreement must be performed by an Authorized Dealer. Repairs and replacements of parts due to "damage," which includes, but is not limited to, collision, misuse, and lack of or improper maintenance of the Vehicle, are not covered by this Agreement.
- 4.2. Within the scope of this Agreement, any covered defective parts in Your Vehicle will be exchanged or repaired by an Authorized Dealer. MBUSA recommends Genuine Mercedes-Benz Parts, exchange units, and factory-approved accessories for all of Your Vehicle's replacementparts. These parts meet the same exacting quality control standards asthe original equipment on Your Vehicle and comply with all applicable Federal and state safety regulations
- 4.3. You are required to service Your Vehicle at the mileage intervals specified in the Service Information Booklet for the Vehicle. These services help assure the proper operation of the Vehicle.
- 4.4. Failure to follow the required Mercedes-Benz service maintenance schedule using specified materials, fluids, and parts, at the specified intervals could cause vehicle damage not covered by this Agreement.
- 4.5. In no event shall any repairs or replacements made under this Agreement constitute any extension, amendment, or modification ofthe term of the Vehicle Warranty, the Term of this Agreement, or any part thereof.

5. EMISSION SYSTEM WARRANTY AND SERVICE

MAINTENANCE

- 5.1. Where applicable, Your vehicle may qualify for any remainingportion of the Emission Systems, Emission Performance, or California Emission Control System warranties.
- 5.2. For detailed information concerning emission control system maintenance and/or applicable emission system warranties, please refer to Your new Vehicle warranty booklet. If You want additional information concerning tuneup specifications or emission control system maintenance jobs, we recommend a special *Maintenance Manual*, which is available from an Authorized Dealership or directly from MBUSA.

6. NORMAL MAINTENANCE

- 6.1. Maintenance service as recommended in the Vehicle's Maintenance Manual can be performed by any qualified service outlet. However, we recommend that all maintenance service work be performed by Authorized Dealers who have the factory-trained technicians, tools, diagnostic instruments, and service reference literature necessary to perform the recommended maintenance correctly and systematically.
- 6.2. The Owner's Manual and Service Information Booklet include specific recommendations regarding the use, operations, and maintenance of the Vehicle. To maintain the validity of this Agreement, You must follow correct Vehicle operating procedures and have Your Vehicle servicedas recommended by the manufacturer during the Agreement Period.
- 6.3.Cleaning and polishing, lubrication, filters, engine tune-up, replacing wiper blades or wiper rubber inserts, brake pads, sensors and rotors/discs, clutch discs, pressure plates, and function checks of relevant batteries and other electric-driven vehicle components are some of the normal maintenance services the Vehicle requires and are not covered by this Agreement. See Service Information Booklet for details.

6.4. If requested, proof of required service, including receipts showing date and

- mileage of the Vehicle at the time of service, must be presented before any repairs under this Agreement commence.
- 6.5. This Agreement and/or the Service Information Booklet must be available for review by the repair facility. Failure to provide maintenancerecords may result in the denial of claims.
- 6.6. This Agreement does not provide coverage for any part or system damaged as a result of improper maintenance or lack of maintenance.
- 6.7. MBUSA's retention of broken parts, for inspection or other use, may be required for any repair work.

7. WHAT IS NOT COVERED

7.1. DAMAGE DUE TO LACK OF MAINTENANCE: Lack of proper maintenance of the Vehicle as described in the Service Information Booklet.

7.2. DAMAGE CAUSED BY NON-APPROVED PARTS OR FLUIDS:

- 7.2.1. Damage or malfunctions caused by the use of equipment and parts that are not Mercedes-Benz original equipment or Mercedes-Benz-approved spare parts or accessories
- 7.2.2. Damage to or malfunctions of a covered part caused by the use of service parts or fluids, such as paper oil filters, improperengine oil, fluids, cleaners, polishes, or waxes, which are non- approved by Mercedes-Benz.
- 7.2.3. Damage or malfunctions resulting from poor fuel quality or from blending additional fuel additives, other than those expressly approved for use in exceptional circumstances by MBUSA are not covered by this Agreement (see Operator's Manual for the Vehicle).

7.3. DAMAGE DUE TO ACCIDENTS, NEGLIGENCE, FRAUD,

IMPROPER ADJUSTMENTS, DISCONNECTION, TAMPERING, OR MISUSE:

- 7.3.1. Damage due to accidents, negligence, fraud, improper adjustments, modification, alterations, disconnection, or tampering.
- 7.3.2. Damage from objects striking the Vehicle is not covered by this Agreement.
- 7.3.3. Damage due to misuse of the Vehicle including, but not limited to, driving over curbs, overloading, improper operation, operating without regard to vehicle warning lights, storage, or transport is not covered by this Agreement. (Proper vehicle use is described in the Operator's Manual.)

7.4. DAMAGE CAUSED BY OUTSIDE INFLUENCES AND THE ENVIRONMENT:

- 7.4.1. Damage from accidents or acts of nature or other events beyond the control of MBUSA is not covered by this Agreement (e.g., fire, flood, earthquake).
- 7.4.2. Resultant damage from factors such as, but not limited to, fuel or fluid contamination, corrosion, mold, and algae is not covered by this Agreement.
- 7.4.3. Parts made from cloth or leather (e.g., upholstery, convertible tops, trim items), wood, sheet metal/body panels, paint, or chrome which have been affected by airborne fallout, such as chemical and tree sap, or by road salt, hail, windstorm, or other environmental factors are not covered by this Agreement.
- 7.5. DAMAGE DUE TO MODIFICATIONS OR ALTERATIONS: Alterations by changing or adding to the Vehicle can adversely affect its performance, reliability, and longevity, and are not covered by this Agreement.
- 7.6. ALTERED ODOMETER: No coverage under this Agreement shall apply

- to the Vehicle if its odometer has been altered or the actual mileage cannot be determined.
- 7.7. DAMAGE CAUSED BY IMPROPER BODY REPAIRS: Damage or malfunctions caused by body repairs not performed in accordance withMBUSA-specified repair procedures or otherwise improperly performedare not covered by this Agreement.
- 7.8. SHOCK ABSORBERS / SUSPENSION STRUTS: are not coveredby this Agreement.
- 7.9. **TIRES**: Tires are not covered by this Agreement.
- 7.10. **GLASS**: Glass is not covered by this Agreement.
- 7.11. **PAINT AND OTHER APPEARANCE ITEMS**: Paint and other appearance items are not covered by this Agreement.
- 7.12. **CHANGES IN DESIGN**: MBUSA, as the manufacturer, has reserved the right to make any changes in design or to make additions to or upon its products without incurring any obligations to install the same equipment on motor vehicles previously built.
- 7.13. OTHER: The soft top which includes fabric top, headliner, glass/plastic window; cellular telephones; Bluetooth dongles; communications service infrastructure such as, but not limited to, cellular telephone networks, GPS satellites availability, Internet, and map data content are not covered by this Agreement.
- 7.14. **BATTERIES / ELECTRIC-DRIVE**: Vehicle batteries of any type and the maintenance, service and replacements of/to the Vehicle's battery or, any components thereof, are not covered by this Agreement.
- 7.15. ITEMS, SYSTEMS, PARTS AND ACCESSORIES NOTIDENTIFIED AS COVERED: If a system, item, part, or accessory is not listed in the section of this Agreement entitled "WHAT IS COVERED," it is not covered by this Agreement.
- 7.16. **EXTRA EXPENSES**: This Agreement does not cover payment for loss of use of the vehicle during warranty repairs, lodging bills, substitute

- transportation rentals, or other travel costs, telephone calls, loss of pay, or other economic loss or consequential or secondary damages.
- 7.17. **EXTENDED WARRANTY REPAIRS AT NON-AUTHORIZED DEALERS**: Otherwise covered repairs when the prescribed repair is not performed by an Authorized Dealer are not covered by this Agreement.
- 7.18. FAILURE TO FOLLOW THE TERMS OF THIS AGREEMENT: This Agreement does not cover any damages resulting from the failure to obtain services under this Agreement by following the procedures described under the "How to Obtain Service" section.
- 7.19. LIABILITY FROM USE OF THE VEHICLE: Liability for damage to property or injury or death of any person arising out of the operation, maintenance, or use of the Vehicle, whether or not related to the prescribed services, is not covered by this Agreement.
- 7.20. **TAXES**: Any and all taxes required on services under this Agreement, except where prescribed by law, are not covered by this Agreement.
- 7.21. PRE-EXISTING CONDITIONS: No coverage is provided under this Agreement for a condition which existed prior to the Agreement purchase date or whichexisted prior to the expiration of the manufacturer's original Vehicle warranty.

8. LIABILITIES AND LIMITATIONS

- 8.1. The performance of work for prescribed repair as stated under this Agreement is the only remedy available under this Agreement.
- 8.2. The implied warranties of merchantability and fitness for a particular purpose are limited to the duration of this Agreement as defined in Section 1 of this Agreement.
- 8.3. MBUSA WILL NOT BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL LOSS OR DAMAGE UNDER THISAGREEMENT,

INCLUDING, BUT NOT LIMITED TO, LIABILITY FOR INJURY, LOSS OF LIFE, PROPERTY DAMAGE, LOSS OF USE, LOSS OF TIME, INCONVENIENCE OR COMMERCIAL LOSS, OR BREACH OF IMPLIED OR EXPRESSED WARRANTIES. ANY AND ALL SUCH LIABILITY IS EXPRESSLY EXCLUDED.

- 8.4. Some states do not permit the exclusions or limitations of incidental or consequential damages, so these limitations may not apply to You.
- 8.5. THE MAXIMUM AMOUNT OF LIABILITY OF MBUSA WITH RESPECT TO ITS OBLIGATIONS UNDER THIS AGREEMENT SHALL NOT EXCEED THE ACTUAL MARKET VALUE OF THE VEHICLE.

9. HOW TO OBTAIN SERVICE

- 9.1. Contact Your Selling Dealer, or any Authorized Dealer:
 - 9.1.1. Schedule a maintenance appointment for the appropriate maintenance service.
 - 9.1.2. Bring the Vehicle along with the "Service" booklet and this Agreement to Your Selling Dealer or any Authorized Dealer.
 - 9.1.3. Sign the repair order upon completion of all repairs and replacements.
 - 9.1.4. Pay for any non-covered services and/or parts and taxes, if applicable.
- 9.2. If You require assistance in locating an Authorized Dealer, please call the Mercedes-Benz Customer Assistance Center toll-free at 1-800-FOR-MERCEDES (1-800-367-6372).
- 9.3. Any Authorized Dealer in the United States and Puerto Rico of the owner's choice can perform Extended Limited Warranty services. The Vehicle should be delivered to the Authorized Dealer during normal

service hours. A reasonable time should be allowed after taking the Vehicle to the Authorized Dealer for performance of the Extended Limited Warranty services.

10. MERCEDES-BENZ ROAD SIDE ASSISTANCE

- 10.1. During the Term of this Agreement, You are eligible to receive Mercedes-Benz Roadside Assistance services.
- 10.2. These services include:
 - 10.2.1. In the event of a mechanical breakdown due to a "defect" in a covered part during the Term of this Agreement, reasonable and competitive towing charges to have the Vehicle towed to the nearest authorized Mercedes-Benz Dealer at no charge.
 - 10.2.2. Trip Interruption Coverage: You may be reimbursed up to \$300 per day for actual documented expenses - for up to three days - including the costs of meals, lodging, and substitute transportation. All Trip Interruption claims and documentation must be presented to, and approved by, an Authorized Dealer.
- 10.3. If You require assistance in locating an Authorized Dealer, please call the Mercedes-Benz Customer Assistance Center toll-free at 1-800-FOR-MERCEDES (1-800-367-6372), or visit: https://www.mbusa.com/mercedes/dealers/locator.

11. CANCELLATION

- 11.1. You may cancel this Agreement at any time by submitting to the Selling Dealer or any Authorized Dealer proof of ownership for the Vehicle and a completed written Cancellation Form, which is available from the Selling Dealer or any Authorized Dealer.
- 11.2. If this Agreement is cancelled prior to the date coverage begins, or within the first sixty (60) days after coverage begins, and no claims have been filed, the entire Agreement price will be refunded by the Selling Dealer.

- 11.3. If a claim has been made against the Agreement, or if the Agreement has been in effect more than sixty (60) days, the Selling Dealer will refund an amount of the Agreement purchase price according to the pro-rata method reflecting the greater of the days in force or the miles driven based on the term/miles selected and the date coverage begins, less the amount of any claims paid under this Agreement.
- 11.4. If You cancel this Agreement, cancellation is effective immediately and this Agreement will not be reinstated.
- 11.5. We may cancel this Agreement at any time if any of the following occurs:
 - 11.5.1. Nonpayment of the Agreement charge;
 - 11.5.2. The Vehicle odometer has been altered, disabled, or has been inoperable for more than ten (10) days after the purchase of this Agreement so as to reflect an incorrect or misleading reading;
 - 11.5.3. The Vehicle has been determined to be a salvage, scrap, or dismantled vehicle as defined by applicable state law;
 - 11.5.4. Any material misrepresentations on the part of the Purchaser, including, but not limited to, a submission of a fraudulent claim in connection with this Agreement;
 - 11.5.5. The Vehicle is found to be modified in a manner not recommended by the manufacturer; or
 - 11.5.6. The Vehicle is found to be used as a commercial vehicle.
- 11.6. If We cancel this Agreement, a written notice will be mailed to Your last known address stating the grounds for cancellation, and this Agreement will terminate five (5) days after the postmarked date of the cancellation notice.
- 11.7. Prior notice is not required if the reason for cancellation is due to nonpayment, a material misrepresentation by You to Us or the Selling Dealer, or a substantial breach of duties by You relating to the Vehicle or its use.

- 11.8. THE CANCELLATION PROVISIONS DESCRIBED ABOVE ARE NOT APPLICABLE IN ANY WAY IF THIS AGREEMENT HAS BEEN TRANSFERRED, AND NO REFUND SHALL BE ISSUED TO ANY PURCHASER TO WHOM THIS AGREEMENT HAS BEEN TRANSFERRED.
- 11.9. In the event of cancellation, the lienholder, if any, will be named on a cancellation refund check as their interest may appear. The lienholderwill be named as the sole payee on a cancellation refund if the Vehiclehas been repossessed.
- 11.10. Should the Vehicle be repossessed or deemed a total loss, the Purchaser's cancellation rights under this Agreement shall transfer to the Lienholder or Lessor and the Selling Dealer listed on page 1, and at Lienholder's or Lessor's request, this Agreement shall be cancelled upon receipt of evidence of repossession or total loss and Lienholder or Lessor shall be named as the sole payee of any resulting refund unless MBUSA is instructed otherwise in writing by the Lienholder or Lessor.

12. TRANSFER

- 12.3. This Agreement cannot be transferred if the title transfer of the Vehiclepasses through any entity or individual other than a Private Party Purchaser, or if the Vehicle is sold or traded to a dealership, leasing agency, or entity/individual in the business of selling motor vehicles.
- 12.4. MBUSA will not be responsible or liable if the Purchaser, or the previous Private Party Purchaser of the Vehicle, has cancelled this Agreement without the knowledge of the Vehicle's new owner.
